Statehouses are rapidly becoming the front lines of the PFAS debate—and biosolids are squarely in the crosshairs. As EPA signals next steps on its draft sewage sludge risk assessment for PFOA and PFOS, we anticipate a wave of renewed and expanded state legislation aimed at restricting—or outright ending—land application programs. NACWA has already pushed back on several bills that would have effectively dismantled these programs, and we expect more are coming. This Committee discussion will deliver critical federal updates on EPA's PFAS work in biosolids and preview our state advocacy strategy, including a look at NACWA's newly released State PFAS Guide and Model Legislation—tools the sector will need to stay engaged, informed, and influential.

## Water Quality Committee Meeting

Water quality drivers continue to shape—and in many cases accelerate—major capital and operational investments for clean water utilities. While this Administration has not aggressively pursued new federal standards, states and environmental NGOs are intensifying pressure on utilities to go further and faster. From high-stakes nutrient debates tied to Puget Sound impairments, to escalating PFAS challenges in New England, to increasingly complex and consequential modeling assumptions, the regulatory and technical landscape is shifting. This discussion will highlight the issues NACWA members need on their radar now—and the emerging trends that could drive the next wave of utility decision-making and investment.
